

NOTICE OF PUBLIC HEARING, BUDGET VOTE AND ELECTION OF

NOTICE IS HEREBY GIVEN that, pursuant to Executive Order 202.26 (the “Executive Order”), issued by Governor Andrew Cuomo on May 1, 2020, the annual Library vote and election will be held remotely on June 9, 2020. Pursuant to the Executive Order, the annual election shall take place remotely and qualified voters shall vote only by absentee ballot, to be provided by the Westbury Union Free School District, County of Nassau, State of New York to all qualified voters.

AND FURTHER NOTICE IS HEREBY GIVEN THAT a public budget hearing will be held remotely by the Board of Trustees of the Westbury Memorial Public Library, Towns of Hempstead and North Hempstead, County of Nassau, State of New York on Tuesday, May 26, 2020 at 7:00 PM, and members of the public may attend via teleconference, for the purpose of reviewing the proposed budget and for the discussion of expenditures contained in the proposed budget for the fiscal year 2020-2021. AND FURTHER NOTICE IS HEREBY GIVEN that, said vote and election by registered voters will be held remotely on Tuesday, June 9, 2020 and qualified voters will vote only by absentee ballots mailed to the Office of the District Clerk at Office of the District Clerk, Westbury Union Free School District, 6 Hitchcock Lane, Old Westbury, NY 11568, and absentee ballots must be received by the Office of the District Clerk no later than June 9, 2020 at 5:00 pm in order to be canvassed. Voting shall be held for the following purposes only:

- (a) To approve or disapprove the proposed library budget (supplemented or amended as the case may be) of estimated expenses for the ensuing year as submitted by the Library Board of Trustees.
- (b) The election of three (3) members to the Board of Trustees of the Westbury Memorial Public Library: One (1) member for a full term of five (5) years commencing April 7, 2020 and expiring June 30, 2025. The present incumbent is Ellen F. Hurwitch. One (1) member for an unexpired term commencing April 7, 2020 and expiring June 30, 2023. The present incumbent is Thomas Maxheimer. One (1) member for an unexpired term commencing April 7, 2020 and expiring June 30, 2021. The present incumbent is Scott Cooper.

AND FURTHER NOTICE IS HEREBY GIVEN that, pursuant to the Executive Order, the requirement of signatures on the nominating petitions has been waived and no signatures need be gathered. All age and residency requirements remain applicable. Nominating petitions containing the name and residence of the board candidate must be sent via mail to the District Clerk at Office of the District Clerk, Westbury Union Free School District, 6 Hitchcock Lane, Old Westbury, New York 11568, no later than May 11, 2020 at 5:00 pm.

NOTICE OF REGISTRATION

Potential voters can register with the Board of Elections by filing an online application with the Department of Motor Vehicles (DMV) which will enable the district to identify the qualified voter and transmit an absentee ballot to the voter. QUALIFICATIONS FOR VOTING:

A person must be:

- A. A citizen of the United States of America.
- B. Eighteen or more years of age.
- C. A resident of the Westbury Union Free School District for a period of at least thirty (30) days preceding the election at which he/she offers to vote.
- D. Registered to vote in Nassau County or the Westbury Union Free School District elections.
